YOUR COMMITMENT TO THE CHURCH

Thank you for your commitment to the financial support of MPCC, your church home, and for joining with others to advance the Kingdom for Christ. We are thrilled that you were led here to grow and worship as a part of the body of Christ. We are grateful for the vision you have in participating in the work of God and how God will use you.

WHAT IS ELECTRONIC FUNDS TRANSFER?

The term Electronic Funds Transfer (EFT) includes transfers of funds initiated through an electronic terminal, telephone or computer for the purpose of authorizing a financial institution to debit or credit an account. Many at MPCC have expressed an interest in being able to handle their giving automatically through Electronic Funds Transfer. You can authorize MPCC to automatically withdraw your contribution from your checking or savings account using the enrollment form.

FREQUENCY OF GIVING

You may choose to have funds electronically transferred to MPCC on the 5th or 20th of each month, or contribute on both the 5th and the 20th of each month.

SECURITY/CONFIDENTIALITY

Funds can be withdrawn from your account only with your authorization and transactions are governed by strict guidelines. We are committed to keeping your personal account information in the highest confidence.

CAN I STILL ALLOCATE MY GIVING?

You may continue to designate your gift to any of the church funds:

- **General Fund:** Supports the various ministries and administrative costs of the church.
- **Building Fund:** Supports the church building and property (includes building to build people pledges).
